## 2018 Fee Schedule

### On-Site Sewage Individual Well

<sup>1</sup>Applies to new development, remodel and repair applications.

<sup>2</sup>Additional hours will be charged at our hourly rate of \$165.

<sup>3</sup>Fee reduction on second application when submitted with primary application and site inspection is concurrent. All structures must be on same parcel.

<sup>4</sup>Fee selection is dependent on the severity of the violation(s) as determined by the Health Department Official.

<sup>5</sup>Cost of reporting fees are the homeowner's responsibility and are collected on behalf of the Health Department by the septic service provider.

<sup>6</sup>Fee reduction when application is accompanied by a corresponding On-Site Sewage Application for the same property and the site inspection will be conducted concurrently.

<sup>7</sup>Initial certification fees are 50% of original if application is submitted between September 16 and March 14.

<sup>8</sup>Fees noted for inspection activities apply to Health Department authorized entities.

*Sampling, laboratory and other outside professional and agency service charges are not included in fees or hourly rates unless specified.*
